

Emissions reduction targets

In order to continue our progress to achieving Net Zero, we have adopted the following carbon reduction targets.

Our Emissions have risen in the past year due to the end of the Covid 19 pandemic and the resumption of travel. We believe that we are a low Emitter in our marketplace, despite the increase, and will endeavour to continue reducing emissions where possible. Completed Carbon Reduction Initiatives

The following environmental management measures and projects have been completed or implemented since the **2020** baseline. The carbon emission reduction achieved by these schemes equate to $9 \text{ tCO}_2\text{e}$, a 50 % ge reduction against the **2020** baseline and the measures will be in effect when performing the contract

We have successfully switched to a 100% Work from home Policy which has made all commuting zero for staff. We also have ensured that as many meetings as possible are online rather than face to face with clients. We have also adopted policies of purchasing refurbished Electric Hardware where possible and a paperless desk policy. We offset all carbon production and as a result we are certified Net Positive.

Due to the limit of how much a company of our size and working practices can reduce our footprint, in the future we hope to implement/continue the following measures such as:

- We are encouraging staff to move their power supply to greener producers where possible.
- We will continue to assess our supply chain and endeavour to work with organisations that are also low emitters or Carbon Neutral.
- Continue to assess our purchasing to improve our recycling and refurbishment policies
- Continue to educate our staff with the appropriate training on environmental issues
- Encouraging Staff to implement their own energy consumption at home and in the workplace
